## 1. INTRODUCTION

Pacific Scientific has become aware of a few operators who require copies of flame resistance testing certifications with the acceptance of restraint products. The FAA/JAA 8130-3 from the authorized TSO holder of the part number being manufactured or repaired certifies complete compliance with type design criteria which includes all necessary flame resistance testing and certification for the unit received.

The receipt of an FAA/JAA 8130 issued by Pacific Scientific insures proper materials were used in the manufacture or repair of Pacific Scientific restraint products.

Pacific Scientific does not authorize the repair or replacement of webbing on its restraint products. Pacific Scientific products that have been rewebbed by third parties no longer meet the requirements of the TSO issued to Pacific Scientific for those part numbers and should be removed from service.
